If someone else is supposed to pay for it and they aren't, we can't cover it. There have been changes at the state level to cover fluoride. We can help cover this for one year for the Lassen County Oral Health Program. In the motion we can reimburse invoices for up to \$600. They can order their fluoride as needed and get reimbursed and can order in sections.
