8. ANNUAL EVALUATION REPORT

Presented by Kim Hopkinson

Discussion

Summary

Pathways served 28 families with one child prenatal through age 5 with at least one high-needs characteristic at intake. For July 1st, 2023- June 30th, 2024 Pathways had 1,337 points of contact, 622 additional services, and 497 home visits. Pathways also provided families with 24 referrals to other community resources. Of the 28 families 21 families did complete 35 surveys. There was 100% satisfaction of the people who completed their surveys. All stated that they were treated well. 61% indicated their needs were not met after the referral. Kim Hopkinson tried to reach out further and only got two responses. Those were not included, but were noted as positive.

Roberts stated that most of the dissatisfaction comes from housing referrals. They had 5 housing referrals this year.

Families are always offered services, not all families accept all services.

Hopkins reviewed the 4 goals of Pathways with the First 5 Lassen Commission Board. Pathways uses the Parents as Teachers model to provide services for high needs families through the PAT standards. Recommendations from the 23-24 local evaluation report are to consider the use of a participatory evaluation process and to connect with families to explore potential areas of improvement with the referral process and understanding the impact of expanded programming and braided funding on evaluation activities.

Pathways reports to: First 5 Lassen, PAT, CAL WORKS, and MCAH.

COMMENT: One of the funding sources requires that Becky Roberts uses the Visit Tracker Database. Kim Hopkinson asks if we can possibly move away from our current database, ODM with Bailey Data Management, and have Pathways only use the Visit Tracker Database. This new database may not have the same kind of reports that we need. Hopkinson suggests that we build a referral report system through survey monkey for example, to make up for what the Visit Tracker Database is missing. By moving away from ODM and using the new database, it would reduce our budget by \$5,000. It would cost more for SEI to become fluent in using the new system in the beginning.

Pathways has started using Visit Tracker and has been entering all families seen since July. Visit Tracker will have a record of every family enrolled since July 1st. Visit Tracker is much more efficient and easier to use for the staff.

Roberts will need access to the database for a few weeks into October to make sure everything is transferred over to Visit Tracker.

Roberts suggests we pay through October for ODM to give her time. Clark will contact Jeff Bailey to see if he can revise his bill.

Pathways Sustainability Plan

We are in our last year of grant funding for Lassen Links. We want to make sure we know what we can do so we don't engage in things we can not partake in. Clark is hoping for information by our October meeting.

14. LASSEN LINKS UPDATE

Discussion

Summary

Lassen Links has grant opportunity through Partnership. Clark is submitting the grant application today. It is for up to \$150,000. We would contract this out for staff support, referral support and community support. This would also supply support for Community Health Workers and Enhanced Care Management support. If we get accepted there is ongoing funding and additional support for these activities that we are building to be sustained.

Janelle Morgan from Pathways was denied for the CHW class. They got an email that there will be more classes next year. Debbie Jones from Northeastern (Health Educator) and Ronda Hall were accepted.

CHW: Community Health Worker - help medical recipients to get additional services that are available to them. It is a bridge to help community members get routed to services they need and help them find those services.

CPHW - Theresa Woodbury is certified. Comprehensive Parental Health Worker. Northeastern gets paid for her to do this and they pay her.

First 5 hopes to pick up the indirect services.

FFPSA -Family First Prevention Service Act- This team is out of probation, T1 Lassen links, T2 wrap around. Any families that have SCARS reports that are unfounded are sent to a screener.
